- Lead iOS developer.
- Architected and implemented logic for location-based coupon and notification app using Swift 3.
- Conceptualized and built beautiful and engaging map feature which allowed for a single pin to elegantly present information to users about multiple coupons at that single location.
- Increased reliability of notification deliveries from sporadic to near perfect by eliminating reliance on background RESTful API calls, and instead, instantly retrieving local information from Core Data.
- Worked with design, client, and development teams to ensure perfect quality and meet tight deadlines.

- Designed and created native Android app to project a store-associate's device to a nearby TV.
- Implemented all native WebRTC logic, including socket-signaling emitter, and node.js backend server.
- Organized large codebase into easily readable and very maintainable discreet classes and projects, allowing for intuitive, well-defined abstraction.
- Carefully managed activity and custom-class lifecycles to eliminate memory leaks, and to ensure live-stream would never be interrupted while app is in background.

- Abstracted shared code into separate frameworks for easy reuse by the remote iOS team.
